 - Pres-Elect, Pres, and Past-Pres.

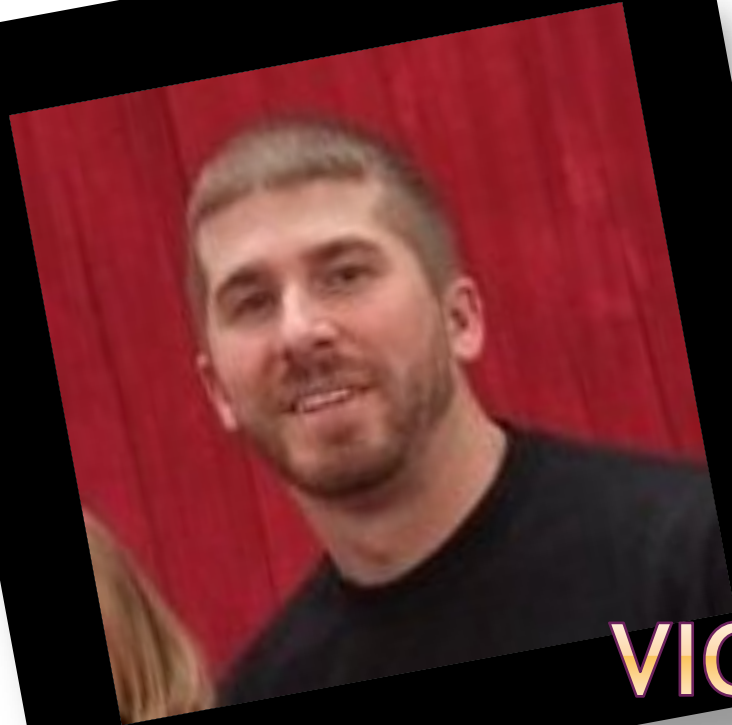
