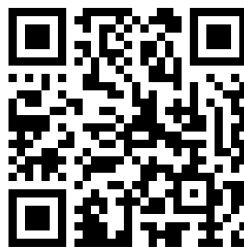

AARC House of Delegates - Highlights

The AARC House of Delegates Winter Meeting met in November in person in New Orleans. The last meeting was winter of 2019, so it was great to see people and network with like colleagues.

The AARC Policy and Guide Committee recommendation is that the Policy and Guide Manual and Historical Handbook be revised. I sit on this committee and will keep Nebraska RT practitioners updated on the progress and approval.

The Resolution: # 67-22-4 from Louisiana was resolved that the AARC Board of Directors and Executive Office collaborate with the State Affiliates Charters and the House of Delegates to develop an Early Professional Leadership Council that is given voice an input on the direction that the AARC is going for the future.

CHARTERED AFFILIATE COMMITTEE: The Chair presented an instructional video for Affiliate Reporting which he will share on the HOD/President AARConnect page. By engaging the affiliates that are due to report in 2023 in the 4th quarter the year prior to their reporting year, we hope to avoid tax season conflicts that have posed many challenges this year. To support efforts of timely reporting, the committee is providing dedicated liaisons to each affiliate to assist with any questions or concerns. Affiliates may email CAC@AARC.org with any questions on the reporting process. The affiliate House of Delegate that is your liaison is HOD member Dr. Fuchs.

AARC membership is at 39,483. Member retention: 69% (up from 67% in August).

NBRC- will be funding over \$2 million by giving \$5,000 to CoARC accredited respiratory care programs. The Certified Asthma Educator Exam Program will fall under the NBRC for the AE-C credentials. The high cut NBRC exam will be moving to a single exam in the year 2027. A high cut TMC score has more probability of passing the CSE thus moving to one exam.
